1. Purpose of the MOU

2: Responsibilities of DALMIA BHARAT FOUNDATION



5. Confidentiality

5.1. Both parties acknowledge the confidentiality of information that may be shared provided among the parties from time to time, under this MoU. Both parties agree not to disclose the same to any outside party, unless such information is,

(i) Part of the public domain at the time of disclosure or

(ii) Require to be disclosed in accordance with the applicable laws of the country.

6. Arbitration and Applicable laws -

6.1. The parties hereby agree that any dispute arising in connection with this MoU shall first be addressed mutually by conciliation between the Parties. If the said Parties are unable to resolve the dispute mutually, the dispute shall be referred to a sole Arbitrator appointed under the Arbitration and Conciliation Act, 1996 whose decision shall be final and binding on all parties.

6.2. In case an aggrieved party seeks judicial remedy, the petition shall be filed within the jurisdiction of High Court of Karnataka, Dharwad bench.

7. Force Majeure-

7.1. No failure or omission by any of the parties to perform any of the terms and conditions under this MOU shall give rise to any claim against such party or be deemed breach of this MOU if such failure or omission arises from an act of God, war or military operations, national or local emergency, natural disasters (fire, lightning, flood or such similar disasters), or any other reason which lies outside the control of the Parties.

8. Validity of the MOU

This MOU shall come into force on May 18, 2024 and shall be valid for 3 year and MOU will be renewed post validity period on mutual agreement between both the parties.

9. Effect of invalidity of any clause of MoU on validity of MOU

The invalidity of any provision of this MOU shall not invalidate other provisions or the MOU. Any such gap should be duly modified through amendment to the MOU in writing, with mutual consultation among all the parties.


